## **GOOD NEWS!**

The Tourist Visa (TR) is back and tourists are allowed to enter the Kingdom. Still a quarantine is mandatory – which means, travelling to Thailand is possible, but only recommendable for a longer period of time („longstay“).

Therefore we offer you special rates for longstay bookings in our hotel. You will find these offers at the end of this guideline.

Throughout the following pages we hope to be able to make the new 60-day Tourist Visa (TR) application process a little bit easier to understand.

We want you to help understanding the requirements for the Tourist Visa and hoping this guideline will give you some useful information.

# THE 60 DAY TOURIST VISA (TR)

## WHAT IS IT?



The Tourist Visa (TR) was announced on November 4th and will be available to all nationalities. This visa is in addition to the Special Tourist Visa (STV).

Thailand relies heavily on income from tourism that also supports some 8 million workers across various sectors. This huge loss in income has seriously affected the economy. However, the TR is seen as a way to reboot the country quickly, yet safely.

Initially, applicants can apply for a minimum 60-day tourist visa, that can be extended for a further 30 days at any immigration office in Thailand.

# WHO CAN APPLY?

As of November 4th, citizens of any country are eligible to apply for the 60-day Tourist Visa (TR)



According to the Ministry of Foreign Affairs (MFA), residents and visitors of every country can now apply for a 60-day Tourist Visa through the Royal Thai Embassy in the country they are currently in.

## Highlights:

- The TR is valid for a single entry into Thailand for tourism purpose only
- The validity of TR is 3 months from the date of its issuance
- It allows a stay for 60 days + 30 days extension (90 days total)
- Can be changed to OA or B visa once you are in the Kingdom



## How do i get the VISA

**3 steps needed**

1. Apply for the Visa  
at your Royal Thai Embassy (RTE)
2. Get the Certificate of Entry (COE)

3. Present all documents needed  
when commencing the flight

## Step 1: VISA



Please check with your Royal Thai Embassy (RTE) the explicit requirements, as they might vary depending of the country you are in

### What you need to apply for the Visa:

- Your **passport**
- Passport **picture**
- **Travel booking confirmation:** Proof of accommodation in Thailand e.g. hotel booking, invitation letter from family or friend in Thailand
- Copy of **health insurance** policy which covers COVID-19 related medical expenses in Thailand no less than 100,000 USD for the whole period of your stay in Thailand
- **Declaration form**

## Step 2: Certificate of Entry (COE)



Only online available



After you received your Tourist Visa (TR), you need to get the Certificate of Entry. Since november, this can be done only via online application.

The Ministry of Foreign Affairs (MFA) announced:

„After visa has been granted, tourist visa holders have to apply for the certificate of entry, with submission of bank statements, health insurance, confirmed flight and ASQ hotel booking, as stated above.“

Therefore you need three things to do once you received the Visa:

1. Book your flight
2. Book your ASQ
3. Apply for COE

## Step 3: Flight to Thailand



Checks of your documents:  
- before your flight  
- upon arrival



What you need to present at airlines check-in counter and upon arrival in Thailand:

- The **Certificate of Entry**
- **Declaration form**
- **Fit to Fly** health certificate, issued within 72 hours before departure – this is a statement by a doctor that you are free from symptoms and fit to fly (must be separate from COVID test)
- **COVID-19 test result**, with a laboratory output indicating that COVID -19 is not detected (COVID test must be by RT-PCR method), issued within 72 hours before departure
- Copy of your **health insurance** policy which covers COVID-19 and no less than 100,000 USD
- Copy of your confirmed booking at an **ASQ hotel**
- **T.8 form**





## Alternative State Quarantine

**In case you need help with finding a suitable ASQ, we will be happy to provide you with our support!**



For every foreign person entering Thailand, a quarantine period is still mandatory. Currently it is a period of 14 full days - arrival and departure days are not counting. Therefore it will be 15 nights in the ASQ.

The Kingdom is discussing a reduction of the quarantine period, down to 10 days only, but this is pending.

You can book your ASQ independently and choose a variety of options for every budget. You will get in all ASQ daily temperature checks and tests for Covid. If negative, you will receive a certificate at the end of your quarantine period.

After the quarantine you are allowed to move around in Thailand wherever you want. Just keep in mind that for the visa application you need to have a confirmation of the hotel, where you will go after the quarantine initially.

# SUMMARY

The TR is available now but not suitable for short term visits!



A quick hop to Thailand just for a couple of days is still not possible, as long as the quarantine is mandatory.

BUT: If you plan to come to Thailand for a longer period, let's say a month or two, this new visa will give you the opportunity to spend unforgettable moments.

Also it is the perfect solution for everyone struggling with any other type of visa. **You can get the tourist visa, come to Thailand, and change to another visa type (O, B, ED) once you are in the Kingdom.**
